1. Introduction

Boxers in Need (BIN) Ltd ("we", "our", "us") is a registered organisation based in the United Kingdom. We are committed to protecting your personal data and respecting your privacy.

This Privacy Policy explains how we collect, use, store, and protect your personal information, whether you're a supporter, donor, volunteer, beneficiary, partner, or visitor to our website.

2. Who We Are

Boxers in Need (BIN) Ltd (Boxers in Need) supports injured and retired boxers, and amateur boxing gyms in deprived areas across England.

We are the Data Controller for the personal information we collect.

3. The Information We Collect

We may collect and process the following personal information:

a. Information you give us directly:

• Name, address, email, and phone number

- Donation details and Gift Aid information
- Information when you sign up for newsletters, events, or volunteering
- Details you share when applying for support or funding

b. Information we collect automatically:

- IP address, browser type, and device information (for website visitors)
- Cookies and analytics data to improve our website performance

c. Information from third parties:

- Publicly available data (e.g., Companies House, social media)
- Information from partner organisations (e.g., fundraising platforms such as JustGiving or GoFundMe)

4. How We Use Your Information

We use your personal data to:

- Process donations and claim Gift Aid
- Keep in touch about our work, events, and campaigns (only with your consent)
- Manage volunteers, grant applications, and beneficiary support
- Comply with legal and regulatory obligations
- Improve our website and services

We will never sell your personal data or share it with third parties for marketing purposes.

5. Legal Basis for Processing

We process your data under one or more of the following lawful bases:

- Consent where you have given clear permission
- Contract where processing is necessary for an agreement with you
- Legal obligation where we are required by law (e.g. HMRC for Gift Aid)

• Legitimate interests – where processing helps us achieve our charitable aims in a way that does not override your rights

6. How We Store and Protect Your Data

Your information is stored securely in password-protected systems and, where in paper form, in locked storage.

We take appropriate technical and organisational measures to protect your data against loss, misuse, or unauthorised access.

Data is only kept for as long as necessary:

- Donations and Gift Aid: 6 years (for HMRC purposes)
- Volunteer or beneficiary records: as long as your involvement continues
- General contact data: until you ask us to delete it

7. Sharing Your Information

We may share your data only when necessary:

- With service providers who help us run our operations (e.g., accountants, IT support)
- With HMRC for Gift Aid claims
- With regulators or law enforcement when required by law

All partners are required to comply with data protection law and keep your data secure.

8. Your Rights

Under UK data protection law, you have the right to:

- Access a copy of the data we hold about you
- Request correction of inaccurate information
- Request deletion of your data ("the right to be forgotten")
- Withdraw consent at any time
- Object to processing or request restriction

• Data portability (receive your data in a reusable format)
